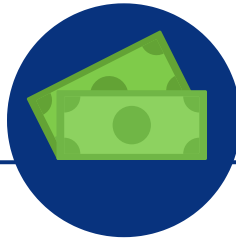
DISTRICT COVID INFO

Students are to grab a breakfast meal and eat in designated areas

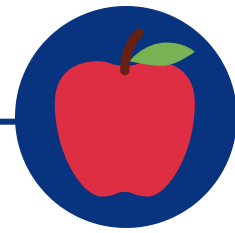
No congregation will be allowed
