General Conditions

Scope of the Proposal:

- 1.1 Dickinson ISD is accepting proposals from potential vendors to provide contracted services that may include training, instruction, assessment, consultation, or special services on an “as-needed” basis for students or staff. Services may consist of information, advice, opinions, recommendations, demonstrations, or direct assistance such as studies, analysis, evaluations, performances, or speeches. Potential vendors who meet requirements will be recommended for approval as a vendor. **Vendors who previously responded to a RFP for general contracted services need not respond again.** Services may include but are not limited to the following:

- Bilingual Assessment, Diagnosis, or Evaluations

- 1.2 This Proposal is as follows: Notice to Bidders, General Conditions, Special Conditions, Proposal Price Sheet, Deviation and Compliance Form, Non-Collusive Bidding Certificate, EDGAR Certifications, Criminal Notification/Felony Conviction Notification, Debarment Certification, Resident/Nonresident Certification, Vendor Employment Certification, Conflict of Interest Form, W-9 Form, instructions for filing form 1295 with the Texas Ethics Commission, and confirmations as per Texas House Bill 89 and Texas Senate Bill 252.
- 1.3 This agreement will go into effect September 14, 2021, and shall renew annually. Recommendations will be made to the Dickinson ISD Board of Trustees monthly to add vendors as necessary. As services will be on an “as-needed basis,” there is no guarantee

that the District will utilize any particular vendor at any time. Should an approved vendor choose to be removed from the DISD list that vendor need only request removal in writing to the DISD Business Services Department.

- 2.0 It is not the policy or practice of Dickinson ISD to purchase on the basis of low bid alone.
- 2.1 Agreements for service will be put into effect by means of a purchase order executed by the DISD Business Office. All agreements between vendors and the District shall adhere to the statutes of the Uniform Commercial Code, official text. The parties agree that the laws of the State of Texas shall govern the rights of the parties and the validity and interpretation of any purchase order contract or service agreement.
- 3.0 Dickinson Independent School District will pay all invoices for service no later than 30 days from date of acceptance or delivery as set forth in the specifications for this bid.
- 4.0 Pricing on purchases shall remain firm for the duration of the contract or as specified by the bidder.
- 5.0 The District is exempt from all Federal, State, and Local taxes.
- 6.0 Dickinson ISD does not accept faxed or email bids. An original signature on the Bid Acknowledgement Form and the Proposal Price List included in the sealed envelope is the only acceptable form of proposal submittal.
- 7.0 Bidders are invited to be present at the opening of the proposals on the date and time specified, however are not required to be present.
- 8.0 The District reserves the right to award contracts for any, all, or none of the parts and/or items of the proposal request.

Any award under this procurement process is not exclusive and DISD reserves the right to purchase goods and services from other vendors when it is in DISD's best interest.

The non-Federal entity must report all suspected or reported violations to the Federal awarding agency.
